

## Legacy Builder Options

You can include Rebuilding Together Alexandria in your estate plan as a lasting and financially wise way to make a gift.

Bequests can take several forms:

- ★ A specific bequest is a gift of something designated by the donor, such as a specified amount of money, security, piece of real estate, or other asset. Suggested legal language is “I leave (exact dollar amount or asset) to Rebuilding Together Alexandria, 2210 Mount Vernon Avenue, Alexandria, VA 22301, Tax ID#54-1389286, to be used for general purposes.”
- ★ Another form of a specific bequest is a percentage of an estate. Suggested legal language is “I give and bequeath the sum of ( ) or ( ) percentage of the rest, residue and remainder of my estate to Rebuilding Together Alexandria, 2210 Mount Vernon Avenue, Alexandria, VA 22301, Tax ID#54-1389286, to be used for general purposes.”
- ★ Another option is to name Rebuilding Together Alexandria as a beneficiary of a retirement account or life insurance policy.

Your financial advisor or attorney can discuss your options to determine the best plan for you and your family.

RTA and our volunteers provide services year-round to homes and non-profits throughout the community, and we carry out a home repair blitz on 50-70 homes yearly in April. Services include plumbing, electrical, door & lockset repair, roofing, heating, the installation of wheelchair lifts and ramps, stairway lifts, window repair, grab bars, painting, and so



much more. Nearly 1,000 volunteers annually make a difference in their neighborhoods and ensure that residents, particularly the elderly and physically challenged, live safely.
